Release of Liability and Assumption of Risk and Indemnity Agreement

In order to participate in the IQuest Global Enrichment Center's Program (the Event), all participants (and their parents or legal guardians, if applicable) must read and agree as follows:

Waiver of Liability: As the legal parent or guardian of the participant, I am aware that despite the best of intentions, injuries may occur in the IQuest Global Enrichment Center (also known as IQuest) classroom or outdoors. I understand that while IQuest strives to foster safe habits and practices, children can present dangers to themselves or others and that accidents can happen. **IQuest reserves the right to dismiss a student whose conduct is dangerous, illegal, or unsatisfactory at the discretion of the Director, or is disruptive and detrimental to the center and/or other students. No refunds are given to dismissed students.**

In the case of accident or sickness, IQuest has my permission to secure such medical attention for my child as is deemed necessary. All expenses will be the responsibility of, and shall be paid for by, the parents or guardians. I hereby give my consent for the participant to join in all activities and engage in interactions with fellow students and artist/experts at IQuest. I and my representatives hereby agree to waive any right to seek compensation for damages incurred by the participant at any time and for any reason and release IQuest, its staff, experts, teachers, assistants and representatives from any and all claims of responsibility.

Assumption of Risk: I, the undersigned hereby acknowledges and agrees that I understand the nature of the IQuest Global Enrichment Center programs; that the Participant is qualified, in good health, and in proper physical condition to participate therein; that there are certain inherent risks and dangers associated with the Event; and that except as expressly set forth herein, I knowingly and voluntarily accept, and assume responsibility for each of these risks and dangers that could occur during Participant's participation in the Event at IQuest.
